# MINUTES OF MEETING OF AVENING PARISH COUNCIL HELD ON THURSDAY 20<sup>th</sup> JANUARY 2011 AT 7.30 PM

The following Councillors were in attendance: Cllr M Williamson (Chairman), Cllr A Slater (Vice Chairman), Cllr Mrs C Mitchell, Cllr Mrs C Chesterman, Cllr Mrs E Oliver, Cllr Mrs G Parsons, Cllr J Catterall, Cllr J Parsons.

The meeting opened at 7.35pm

# 94/10 PUBLIC QUESTION TIME

Mr Osborne asked the Parish Council to note the state of the road to Westend. There were three points where the road gets covered in ice because of spring water. The drain is badly sited. Avening Park drain is full of rubbish and the gulley on the side to Orchard House needs clearing.

Mr Osborne also asked the parish council to note that there were scalpels in the road (previously in driveway of Vale Farm at time of sale and now scattered on highway). The road needs sweeping to clear this. This will be passed onto Highways for their attention.

Mr Osborne also commented on his application to CDC to fell a sycamore tree (with a TPO). He felt reduction was not appropriate as it encourages growth. It has caused boundary wall damage. Mr Osborne confirmed that the tree could be seen from Winter's Lane over the top of the house and also from footpath out to Barton End.

Katie Tew was attending representing the newly formed Avening Conservation Group (ACG). She read over a letter signed by members of the group concerning alleged mess on the Greenacres Farm site (and one other site in the village – which was distinguished from the Greenacres farm site and not in the same ownership). The Parish Council noted the contents of the letter.

Mr Carter asked for a right of reply and stated that every piece of kit on the site was working. Other public comment started to be made and the meeting was called to order.

It was suggested the ACG and the agent for Greenacres Farm speak outside of the meeting in order to try and resolve their differences. Both parties agreed that they would be happy to do this.

Mr Conway (ACG) suggested that the Parish Council might like to encourage applicants to come and talk to the Parish Council before submitting applications to CDC. He had seen this work well in practice previously. The Council were happy to note his comment and would include a note in the next edition of the Villager to try and encourage applicants.

Public Question Time was closed.

### 95.1/10 New Planning Applications

### 11/0009 9/AGPA

Green Acres Farm, Green Way Head, Avening

Proposal: Erection of a polytunnel

Cllr Mrs G Parsons left the room for most of the discussion and also the vote. Cllr Mrs C Mitchell confirmed to the meeting that she was not voting on the matter (she remained present for the discussion and vote).

Mr Carter (agent) had attended to answer any questions on the application. The Clerk advised that siting and design were the only matters to be commented on. The Clerk read over the comments submitted to the previous application (by the Parish Council) for the polytunnel. The application had not changed since then. The application was discussed generally. Mr Carter confirmed that the only alternative to a polytunnel was a greenhouse. This was not the only polytunnel locally, there was one other in Avening and three in Tetbury. The point of the project was to grow and sell local produce to local people. He confirmed that the applicant would carry out further screening of the site if the planning officers requested this.

It was **RESOLVED** (by a vote of 5 councillors able to vote) to submit the same comments as for the previous application:

Siting:

The Parish Council feel that the proposed siting is probably the least visible position in the field – when viewing from the village. However we would request that the planning officer and/or conservation officer makes a site visit to ensure that this is the most appropriate siting.

### Design:

The Parish Council would ask for the conservation/landscape officer to consider whether this specific polytunnel is in keeping with the AONB (where we understand from Policy 7 that the conservation and enhancement of the natural beauty of the landscape and countryside will be given priority over other considerations). We do appreciate that this is a balancing act between maintaining the natural beauty of the landscape and economic conditions (ability for farmer to farm the land successfully/possibly provide jobs). We just wish to ensure the best possible design for the area.

Mr Carter raised issue over Cllr Mrs C Mitchell's presence in the room. The Clerk and Mrs C Mitchell confirmed that Cllr Mitchell was not voting. The questioning persisted. The Clerk advised the Chairman that it was not appropriate to argue points of procedure with members of the public and the meeting was called to order.

The Chairman allowed a question from Mr Conway who asked whether traffic and highways matters were taken into account at the November Council meeting. The Clerk responded that only siting and design issues
