120/21 PUBLIC QUESTION TIME – Mr Conway asked the Council if they were aware of the new planning legislation introduced by CDC. It was explained to Mr Conway that the Parish Council had added their signature and support to a letter produced by Quenington Parish Council objecting to the new procedures. The Clerk explained that the letter was supported by the majority of the Parishes in the Cotswold District. All feeling that their views are being ignored.
A response from Joe Harris at CDC was received this week stating that CDC have no intention of changing the new policy.

123/21 MATTERS ARISING FROM THE MINUTES OF MEETING HELD ON 18th August 2021.

The minutes of the meeting held 18 August 2021 were agreed as a true and accurate record.

124/21 COMMUNITY ISSUES AND PROJECTS

Community Issues

- i. Memorial Hall – The Clerk reported that the Parish Council are now the official Trustees of the Memorial Hall.
Cllr Bendall reported that bookings are starting to increase.
It was agreed to hold a Memorial Hall Trustee Meeting on 27th September 2021.
- ii. Playing Fields Update Following receiving a satisfactory quote from the supplier of the zip wire, the Council agreed to purchase the play equipment and benches requested for the playground.
The Clerk said she had received an offer of two oak trees for the Queens Platinum Jubilee from The Honourable Company of Gloucestershire. The Parish Council agreed it would be a nice addition to the Orchard.
Quercus Arborist have inspected the trees at the playing field and have identified diseased ash trees. There are four that need immediate felling before they become dangerous. Quercus have quoted £1200 to fell the trees. The Parish Council agreed to accept the quote. There are other trees that need attention, but this work is not urgent.
- iii. Build Back Better Restart Fund
Cllr Hirst said that he has been allocated £40,000 over 4 years to cover 15 Parishes to be used to promote activities after Covid. It was asked if the Parish Council could apply for funding towards the hall cost as 2022 marks the Halls centenary. Cllr Hirst agreed that this would be a suitable project.
- iv. 20 MP Speed Limit
The Clerk received an email from the twenty's plenty group asking the Parish to support the campaigns for a 20mph limit to be put on all residential streets, town, and village centres. The Council felt that this is too

much of a blanket cover and reduced speeds should be on an area-by-area basis. It was agreed that the best option would be for the cost of "Traffic Orders" to be reduced as the cost tens of thousands of pounds, putting the applications for lower speed limits out of Parish Councils budgets. Cllr Hirst said that legal fees involved is what increases the costs, but GCC are working on a more financially viable option.

Improved rail services could be on the way for Gloucestershire.

Gloucestershire could benefit from several improvements to rail services, according to recent findings of a Network Rail study.

In addition to supporting planned housing and employment growth in the county, the improvements would also reduce car emissions and contribute towards the council's carbon reduction targets.

The report outlines new infrastructure and rail services that are needed on the route between Bristol and Birmingham.

The recommendations in Network Rail's report include

- A metro-style service between Gloucester and Bristol, which will initially provide two trains per hour as part of the committed MetroWest service improvements and then four trains per hour under Network Rail's proposals.
- An additional Swindon to Gloucester/Cheltenham service.

Working for a 'Greener Gloucestershire'

Organisations in Gloucestershire are joining forces in the lead up to COP26, the international climate change conference. The Greener Gloucestershire collaboration will shine a spotlight on the work across the county tackling climate change.

New Innovation Lab to be launched by Gloucestershire Libraries.

Gloucestershire Libraries are set to unveil the latest in a growing network of 'Innovation Labs' across the county. New 'lab' space will be opened at Gloucester Library later this month with the latest digital design equipment and technical expertise available to boost skills and support employment.

From Tuesday 28 September Gloucester will be the second library in the county to have dedicated space to offer access to creative technology and training in digital skills, following the launch of the first innovation Lab in Coleford in July 2019.

This creative, community space offers access to advance technology, including virtual reality headsets, 3D modelling and printing and a digital design studio plus an experienced technician to advise, train and inspire.
