When village folk were considerably worse off than they are today, some of the richer residents gave money, in trust, to help those less fortunate than themselves.

## There are three charities:-

- I. SANDFORD EDUCATIONAL FOUNDATION Six Trustees administer this foundation, one appointed by the Rector and Churchwardens, two by Gloucestershire County Council, one by the Parish Council and two co-operative members appointed by resolution of the Trustees, each for a term of five years. The main object of this Foundation is for Higher Education. A copy may be inspected at the Parish Clerk's residence.
- 2. POULTON AND CHOMELY CHARITY is administered by the Parish Council. The objects of this Charity are displayed on a large notice board on the interior west wall of the Parish Church.
- 3. THE COX AND DRIVER CHARITY is administered by four Trustees. The object of this Charity is to help provide tools for apprentices.

The Clerk to the Parish Council has always been the Clerk to the Charity Trustees.

Minute Books and Bank Statements are open for inspection at the Annual Parish Meeting.

OLD RECORDS

The old records in our possession make interesting reading.

We learn that "the first public meeting of the Parish took place on 4th December 1894. The purpose of the meeting was to elect Parish Councillors. Mr. Thomas Essex proposed that Mr. Erskine Pollock, Q.C., of Avening Court, be elected Chairman. Nominations, in writing, were collected in alphabetical order by Mr. Morris, Headmaster of the School, and seven were received."

"It was then proposed by Rev. E.W. Edwards, Rector, seconded by Mr. Charles Essex, that the seven gentlemen, all of which were pronounced by the Chairman to be good and valid nominations, were declared to be duly elected."

The first Parish Councillors were:-

Robert Calcutt William Cave
Simon Cox Paul Fowles
Rev. W.E. Frost William Pain
James Singleton

Some of the names will be remembered by older parishioners.

## THE FOUNTAIN

Some of you may have wondered about the memorial on the Cross to William Fowles. Originally it was a drinking fountain and showed to advantage the skill of local stonemasons. Regrettably much of the stone work has been damaged.

William Fowles was a figure of some importance as he was Overseer for the village for a number of years. At one time he farmed at Longman Farm, and owned the two corn mills in the village.

Local people who went gleaning at harvest-time took their grain to be ground at one of his mills. The flour was then stored at home and often kept the family in cakes and puddings for the year.

He also ran the "Bakehouse". He was reputed to be "a hard but just man". People who bought bread from him were allowed to pay at the end of the month. The owners of pigs could obtain their pig-meal from him and pay for it when the pigs were sold.

All his customers were given flour for Christmas puddings and cakes and anyone fortunate enough to have a goose or other large bird took it to the Bakehouse to be cooked in the bread ovens.
