100/06 **PUBLIC QUESTION TIME**

Mr Henry Reid attended to discuss the planning application for the installation of a dish antenna at the transmitting station at Tetbury Hill, Avening. He was submitting his own objections to the application by Argiva for a further dish antenna. The mast and associated dishes were becoming a visual evesore. The current application is fixed to the mast by an arm and increases the visual impact. The top 8 foot of the mast is redundant and should be removed. The mast should be painted green up to a certain height as this reduced the visual impact. The wall should also be built up to reduce the visual impact. Mr Reid had requested a public hearing at CDC.

The Council thanked Mr Reid for his time in looking into the whole issue.

The initial Notice of Vacancy (from CDC) had been displayed as required. No member of the public had come forward asking to fill the vacancy. It was **RESOLVED** not to make specific attempts to fill the vacancy.

106.1/06 **New Planning Applications**

06/02726/FUL Rectory Cottage, Rectory Lane, Avening - erection of first floor extension. Members objected on the grounds that the proposed extension (due to its overbearing size) would be harmful to the character and appearance of the conservation area. The subservience between the extension and original building would be lost. There was little difference between this and the previous application. There were concerns over the level of spoil to be dug out and removed from site.

06/02940/FUL Transmitting Station, Tetbury Hill, Avening installation of 1 x 0.3m dish antenna on existing tower

Members objected to the application on the grounds of the need for the proposed development, environmental considerations - namely the visual impact of the site and the effect on the adjacent conservation area, additional landscaping is necessary (increase the height of the wall and more sympathetic planting scheme on site) and redundant structures should be removed. Members also objected on the basis of the health aspect - no indications have been given as to the levels of exposure.

Action: Clerk to look to make an application to have the mast audited by Ofcom

PLANS FOR THE FUTURE OF THE VILLAGE HALL 107/06

Barbara Pond, Village Halls Adviser from GRCC attended the meeting and was welcomed.

Cllr J Parsons had met with Diana Boulton re the Hall to identify matters that the school would look to improve if they had the opportunity. The school were interested in leasing the hall from the parish council they would then have access to more funding to improve the facilities.

The legal position of the management committee and the parish council as custodian trustees should be considered as it may be necessary to wind up the management committee formally - this would need to be clarified before grant funding could be applied for (as the correct body legally must apply for funding).

The building should be surveyed in order to identify any work and approximate costings of work in order to know how much funding would be needed. Using the ProHelp organisation was a possibility, but also the council should look to see if there was anyone locally who would help out.

The council should also check the risk assessments on the building.

Consultation with the village about the future of the hall was necessary for funding purposes and also likely as a term contained within the deeds for the hall. Ms Pond may have a copy of some documents and would check and send to the Clerk.

Ms Pond was thanked for her attendance.

The main concerns from the school at the current time were the repair of the heating and toilet facilities (there had been some recent leaks). It was **RESOLVED** that the Clerk should address the heating problem as soon as possible and a budget of £500 would be allocated.
