Whilst the conservatory is at the back of the house it can be seen from the High Street and various vantage points across the village eg Rectory Lane and Playing Fields. Members noted that the property was subject to an article 4(2) direction and as such the council would like to see a conservatory that is in character and more sympathetic with the surrounding area. |

The Clerk advised that £150 had been received from HMRC (on account) for filing the Employers P35 online.

24/07 VILLAGE HALL

No volunteers had been found to take over the running of the Village Hall.

Cllr J Parsons' letter to Jon Green was approved by Council.

It was understood that Jon Green had met with Diana Boulton (Headteacher) to explore the hall being handed over to the school to run in conjunction with the Education department at GCC.

Cllr J Parsons would contact Diana Boulton to discuss the situation. He would report back to Councillors.

No councillors had collected the village hall questionnaire from the shop. The Clerk advised that the shop had handed it to someone but they did not remember who. Unfortunately the questionnaires were now missing.
