The Clerk would ask Community First to see if the personal accident cover capital sum and weekly benefits could be increased to be in line with the Allianz Cornhill scheme. In view of the time scale Councillors would accept the quote as it was and deal with amendments to the policy at a later point (if amendments were in fact possible).
