MINUTES OF MEETING OF AVENING PARISH COUNCIL HELD ON THURSDAY 17th SEPTEMBER 2009 AT 7.30 PM

24/09 PUBLIC QUESTION TIME

It was **RESOLVED** to vary the agenda to deal with agenda point 9.9.1 and 9.9.2.

Mrs E Ind, Grants Secretary and Trustee of the Playgroup attended to discuss the Playgroup's grant application for replacement swings, fencing and safety surfacing. The current swings and surfacing were about 20 years old and needed to be replaced and updated to current safety standards. The total cost of the project was estimated to be £8,000 based on national quotes received. The quotes were discussed and it was suggested that local contractors may be able to offer a better deal – as long as they met current safety standards. The playgroup had raised about £4,000 to date for the project. Councillors' confirmed that the project would receive some funding but the final decision would be taken later in the meeting when the council looked at its monthly budget figures.

Mr Jon Glover and Mr Nicholas Winkfield from APFA attended to discuss the group's current grant application for a cycle track at the playing fields. The project would involve excavating a 400m aggregate track around the perimeter of the field for cycling and walking. The total cost of the project was estimated to be around \pounds 6,000. Local contractors had been involved to provide quotes for the work. APFA were advised that CDC's Community Projects Fund should be investigated for a source of funding. APFA had raised about \pounds 1,000 towards the project so far. Councillors' confirmed that the project would receive some funding but the final decision would be taken later in the meeting when the council looked at its monthly budget figures.

The Parish Council would write to CDC Planning Department to confirm that no planning permission was required for the cycle track.

Council were impressed that both groups were being so proactive in pursuing their projects and fundraising.

Mrs Ind and Mr Glover left the meeting.

A letter had been received from a resident asking the Parish Council to look into the increasing numbers of lorries and heavy vehicles travelling along the B4014. The Clerk had made contact with the Police and Gloucestershire County Council.

The Clerk advised that GCC Trading Standards (the organisers of Lorry Watch) had advised that the B4014 weight restriction order (7.5 tons) had been lifted. In this case, the Lorry Watch Scheme would not be appropriate as an order needed to be in place. The Clerk was advised that we might wish to look into applying for another weight restriction order with GCC. It was **RESOLVED** that the Clerk start looking into obtaining a weight restriction order for the B4014.
